## California's Expanded Learning Programs

Before- and afterschool, • summer, and inter-session programs that offer youth safe and supportive learning environments, academic enrichment, caring adults, peer learning, social and emotional supports, and fun!

# 980,000 children

California's publicly funded afterschool programs serve some of the state's most vulnerable children.



84% of children are socioeconomically disadvantaged



90% children of color



33% English language learners



25% of California's homelessness students



## Expanded Learning During COVID-19

- Offering care and programming to the children of essential workers

### **Principles for Expanded Learning Partnerships to Rebuild**

- Develop and maintain systems to sustain and grow partnerships.
- Collaboratively plan and implement services.
- Provide research-based integrated supports.
- Prioritize equity.
- Invest in adult capacity.

Learning hubs typically offer small groups of students inperson academic support and other whole child supports like enrichment, social and emotional learning, exercise, and healthy meals and snacks.



## Baldwin Park Unified + Think Together Partnering to Change the Odds for Kids

### Phase 1: Launched August 2020

- Distance Learning @ 17 sites (Elementary & Middle Schools)
- Coordinated meal distribution once/week & family wellness checks
- Leveraging ASES flexibility

### Phase 2: Launched September 2020

- In-Person Learning Hubs @ 17 sites (Elementary & Middle Schools)
- 34 cohorts; 2 per site
- Leveraging ASES flexibility

### Phase 3: Launched December 2020

- +6 cohorts at 3 existing sites w/longest waitlist
- Leveraging CARES Act Funding

### Phase 4: Scheduled to Launch 02/2021

- +3 sites (High School); 7 cohorts
- Leveraging CARES Act Funding
