

THICKER DATA ON CHILD-CARE SUPPLY AND DEMAND DISPARITIES

Recently we published Part I of *Child Care Indicators 1998*. The present report represents Part II of this same series—aimed at providing local and state-level policy makers more complete data on the current capacity of the child-care system, as well as indicators of where growth in family demand may be observed in the coming years.

Part II provides three new sets of information. First, we have added county-level aggregates for all zip code indicators reported in the Part I volume. Raw counts, such as the number of child slots inside preschools and centers, simply represent total counts for each county. Ratio measures, for instance the number of family day-care home slots per 100 preschool-age children, were calculated for the entire county.

Second, we have extended the zip code tables to include newly available data on how many single parents supported by the state's welfare program report job-related income and the level of these earnings. These indicators help to gauge levels of job demand for women with limited job experience or skills.

The most urgent need for expanded child-care capacity is in those counties and communities where single parents, supported by CalWORKs, are most likely to find jobs. It is in these locales that demand for non-maternal child-care arrangements will climb most rapidly. We also include estimates for the number of families who earn less than 75 percent of California's median income. These numbers suggest an additional layer of working-poor families who could benefit from quality child care and preschool programs.

Finally, we have added new data on the size of the child-care workforce in each county. These data come from the Census Bureau's individual returns for the 1990 census. These counts of how many individuals make a living as a child-care center teacher or director of a family day-care home are somewhat old. But they provide additional insight into the wide disparities in the availability of child-care services across counties. The census data also reveal the large number of local residents who depend upon the child-care industry for their own livelihood.

We enthusiastically thank Diana Gomby and Marie Young at the Center for the Future of Children, David and Lucile Packard Foundation. The Foundation has steadily supported the Network's efforts to standardize data collection on child-care

capacity statewide. More recent grants to PACE have allowed us to analyze supply and demand data and to make it available in more user-friendly forms.

Child Care Indicators 1998 is a publication of the *Child Care Planning Project*, funded by the California Department of Social Services (CDSS). Thanks are due to David Dodds, Bill Jordan, and Martha Lopez for their vision and practical interest in how to help counties and school authorities allocate new child-care and preschool funds more wisely. A parallel grant from the HHS Child Care Bureau further supports our work. A hearty thanks to Pia Divine in Washington D.C. Paul Smilanick at CDSS provided the new data on job earnings for welfare families. Annelie Strath at Stanford University has built our data file over the past two years. UPDATED GUIDE TO INDICATORS, PART II

The previously published Part I of *Child Care Indicators* provided a detailed explanation of the development of the data. We encourage you to review that information as you examine the tables presented below. In particular, we urge you to pay attention to the limitations of the data. These county and zip code data can inform child-care policy makers and planners. But they provide only a tool.

The new zip code level population data presented in this volume are from the 1990 census (columns 33 and 34) and from the California Department of Social Services (columns 35, 36, and 37). The figures for the estimated number of children in families with earnings under \$30,000 (column 34) were calculated by Jon Stiles at UC DATA, a division of the Survey Research Center, UC Berkeley. This information is useful for estimating the number of children potentially eligible for subsidized child care, although it does not account for families who have more than two children and may be eligible for subsidies even when their annual earnings exceed \$30,000.

We have added counts of child-care workers, including all individuals who reported earnings from their work as a center teacher or family home provider (columns 16 and 17). These data were compiled for all zip codes by the Census Bureau. Several agencies co-financed the bureau's development of these data. We thank Martha Moorehouse (U.S. Department of Health and Human Services), Lindsay Chase-Lansdale (Northwestern University), and Sandra Hofferth (University of Michigan) for joining PACE on this effort. These data also allow us to examine the informal market of individual child-care providers.

CHILD CARE INDICATORS, PART II

The indicators below are organized in six tables. The first three tables contain *county level* supply indicators, including raw numbers and ratios which are standardized for child populations resident in each county. The remaining two tables provide data on family demand indicators. The last table offers additional *zip code level* data on potential demand indicators.

If a zip code spans the border between two counties, it is assigned to the county for which a majority of the child-care capacity is located. A listing of the 58 county ID numbers appears at the end of this volume. If you cannot find a particular zip code, please contact PACE.

The numbers appearing next to each definition below correspond to the column numbers appearing in the tables.
